

**THE ARGYLL AND BUTE COUNCIL  
(OFF STREET PARKING PLACES AND CHARGES)  
(HELENSBURGH) (AMENDMENT) ORDER 2006**

Argyll & Bute Council in exercise of the powers conferred on them by sections 35(1) and (3), 35A and 35B of the Road Traffic Regulation Act 1984 (herein after referred to as "the Act") and Part IV of Schedule 9 to the Act, and of all other enabling powers, and after consultation with the Chief Constable of Strathclyde Police in accordance with Part III of Schedule 9 to the Act, hereby make the following order:

1. This Order may be cited as "The Argyll and Bute Council (Off Street Parking Places and Charges) (Helensburgh)(Amendment) Order 2006" and shall come into operation on Monday the Thirteenth day of March Two Thousand and Six.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The Order specified in the Schedule to this Order shall have effect subject to the amendments specified in that Schedule.

In Article 2(i), the following definitions shall be added at the end "initial charge" means an amount payable in respect of an initial period for vehicles left in a parking place and as specified in Article 6; "permitted hours" in relation to parking ticket machines means the hours and days specified in Schedule 2 to this Order, any such day not being a public holiday; "public holiday" means Christmas Day and New Year's Day (or the Monday following when Christmas Day and New Year's Day fall on a Sunday; "parking bay" means a space in a parking place which is provided for the leaving of a vehicle; "car park season ticket" means a ticket issued by the Council in accordance with the provisions of this Order;

In Article 6, the number "(i)" shall be inserted before the words "Every person"; and for the words, "in accordance with Schedule 2 to this Order, by" there shall be substituted the words "in accordance with Schedule 2 to this Order, during the permitted hours, by"; and the following Article shall be added:

"6 (ii) If the initial payment exceeds the time period during which the charges are applicable the time period for which the vehicle may be parked will extend into the next day."

**Extent of Amendment**

The Argyll and Bute Council (Off Street Parking Places and Charges) (Helensburgh) Order 1999 as amended by The Argyll and Bute Council (Off Street Parking Places and Charges) (Helensburgh) (Amendment) Order 2001.

Articles 7 to 13 inclusive shall be renumbered 8 to 14 inclusive and the following Article shall be added:

7 (i) The Council may issue a car park season ticket in accordance with the provisions of this Order to enable the owner of a vehicle to park during the permitted hours in a parking place and during the period specified in said ticket;

7 (ii) If a season ticket is mutilated or defaced or the figures or the particulars on it have become illegible, the holder shall surrender it to the Council and may then apply for the issue of a duplicate;

7 (iii) The charge payable to the Council for a car park season ticket shall be in accordance with Schedule 2 or such other sum as the Council may from time to time determine."

In the Article now numbered 8(vi) the following sub-section shall be added:

"(ix) The amount of excess charge, no ticket charge and irregular parking charge are as provided in Schedule 3 to this Order."

In the Article now numbered 9 (iii), for the words "season ticket" there shall be substituted the words "car park season ticket."

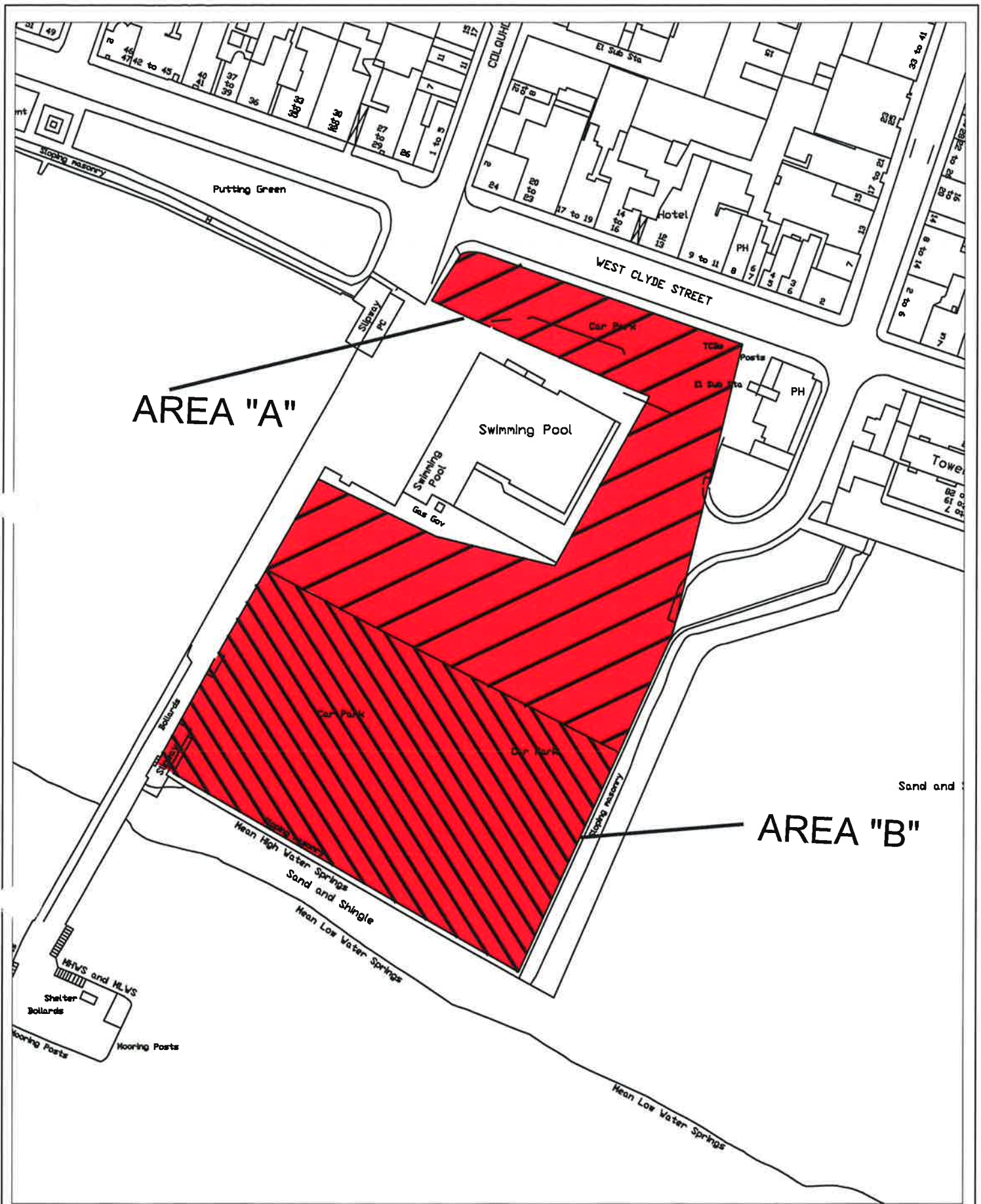
