**(BEANSBURN, DEAN ROAD, INNELLAN DRIVE AND TURNER PLACE, KILMARNOCK)
(WAITING AND LOADING RESTRICTIONS AND LIMITED WAITING)(AMENDMENT) ORDER
2013**

East Ayrshire Council, in exercise of the powers conferred on them by Sections 1(1), 2(1), 2(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended, the Road Traffic (Permitted Parking Area and Special Parking Area) (East Ayrshire Council) Designation Order 2012 and of all other enabling powers and after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the 1984 Act hereby make the following Order—

Citation and commencement

1. This Order may be cited as “The East Ayrshire Council (Beansburn, Dean Road, Innellan Drive and Turner Place, Kilmarnock)(Waiting and Loading Restrictions and Limited Waiting)(Amendment) Order 2013” and shall come into operation on 18 November 2013.

Interpretation

2. (a) A reference in this Order to any enactment is a reference to that enactment as amended by any subsequent enactment.

(b) A reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

Provisions

3. To amend the East Ayrshire Council (Various Roads Within East Ayrshire)(Waiting and Loading Restrictions and Designated Parking Places)(Amendments & Revocations) Order 2012 as specified in the Schedule annexed and executed as relative hereto.
