

**EAST AYRSHIRE COUNCIL**  
**(U63 WHEATRIGGS AND A76, KILMARNOCK)(WAITING RESTRICTIONS)(AMENDMENT)**  
**ORDER 2016**

East Ayrshire Council, in exercise of the powers conferred on them by Sections 1 (1), 2(1), 2(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended, the Road Traffic (Permitted Parking Area and Special Parking Area)(East Ayrshire Council) Designation Order 2012 and of all other enabling powers and after consultation with Police Scotland in accordance with Part III of Schedule 9 to the 1984 Act hereby make the following Order:

**Citation and commencement**

1. This Order may be cited as the "East Ayrshire Council (U63 Wheatriggs and A76, Kilmarnock)(Waiting Restrictions)(Amendment) Order 2016" and shall come into operation on 16 May 2016.

**Interpretation**

2. In this Order unless the context otherwise requires-
  - (a) The following expression has the meaning hereby assigned to it:

"the 1984 Act" means the Road Traffic Regulation Act 1984;
  - (b) A reference in this Order to any enactment is a reference to that enactment as amended by any subsequent enactment.
  - (c) A reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number.

**Provisions**

3. To amend the East Ayrshire Council (Various Roads within East Ayrshire)(Waiting and Loading Restrictions and Designated Parking Places)(Amendments & Revocations) Order 2012.
4. The Order referred to within Column 1 of the Schedule to this Order shall be amended to the extent specified in Column 2 of said Schedule

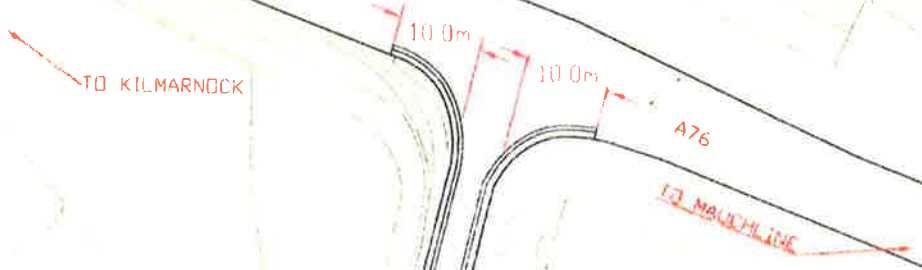
