**ORDER 2018**

On 11 April 2018 the East Dunbartonshire Council made an Order under the Road Traffic Regulations Act 1984 which comes into operation on the 18 June 2018.

This Order introduces an amendment to parking charges that will apply between the hours of 9:00 am and 5:30 pm, Monday to Saturday inclusive, as detailed in the Schedule below. A copy of the Order and plans showing the areas affected may be examined during normal office hours and without payment of fee at the offices of:-

Any person wishing to question the validity of the Order or any provision therein on grounds that the Order is not within the powers conferred by the Road Traffic Regulations Act 1984, or on the grounds that any requirement of that Act or of any relevant Regulation made thereunder has not been complied with in relation to the Order may, within 6 weeks from 11 April 2018 make application to the Court of Session for this purpose.

2. The Order specified in the Schedule to this Order shall have effect subject to the amendment specified in that Schedule.
