(HIGH STREET, ABERLADY) (PROHIBITION & RESTRICTION ON WAITING,
LOADING & UNLOADING) ORDER 2021

TO 324/21

East Lothian Council in exercise of the powers conferred on them by Sections 1 (1), 2(1) and (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Traffic Commissioner and the Chief Constable of Police Scotland in accordance with Part III and V of Schedule 9 to the Act hereby make the following Order.

1. Citation and Commencement

- 1) This Order may be cited as the "East Lothian Council (High Street, Aberlady) (Prohibition of Waiting, Loading and Unloading) Order 2021" and shall come into effect on the 27th day of June Two Thousand and Twenty Two.
- 2) The restriction imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made under the 1984 Act or by or under any other enactment.

2. Interpretation

- 1) In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:-
 - a) "Chief Constable" means Chief Constable of Police Scotland
 - b) "parking attendant" has the same meaning as in Section 63A of the 1984 Act;"
 - c) "Vehicle" unless the context otherwise requires, means a vehicle of any description and includes a machine or implement of any kind drawn or propelled along roads whether or not by mechanical power.

Note:

The restrictions, prohibitions and requirements imposed by this Order are in addition to and not in derogation of any restriction, prohibition or requirement imposed by any other enactment and any exception or exemption to the provision of this Order is without prejudice to the provisions of any other enactment

All words importing the singular also include the plural and vice versa where the context requires.

All signs, carriageway markings etc. shall comply with the Traffic Signs Regulations and General Directions 2016.

3. Articles

- 1) Save as provided in Article 5 of this Order no person shall, except upon the direction or permission of a police constable in uniform or a parking attendant, cause or permit any vehicle to wait, or load onto or unload from any vehicle at any time, on the lengths of road specified in Schedule 1 of this Order and shown on the accompanying plans.

2) Nothing in Article 4 of this Order shall:

- a) Prevent any person from causing or permitting a vehicle to wait in any of the lengths of road referred to in Schedule 1:
 - i) For so long as may be necessary to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the lengths of road so referred to, or the laying, erection, alteration or repair in or near to any of the said lengths of the roads,
 - ii) For so long as it may be necessary to enable the vehicle, if it cannot be used for such purpose in any other road, to be used in pursuance of statutory powers and duties in particular, but without prejudice to the generality of the foregoing to be used as an emergency service vehicle,
 - iii) If the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or if such waiting is necessary to avoid an accident,
 - iv) If the vehicle is in service of or employed by the Post Office and is waiting in any of the lengths of the roads whilst postal packets addressed to premises adjacent thereto are being unloaded from the vehicle or having been unloaded therefrom are being delivered or while postal packets are being collected from premises or pillar boxes adjacent thereto,
 - v) To enable the vehicle to be used by a qualified medical practitioner engaged to a house call

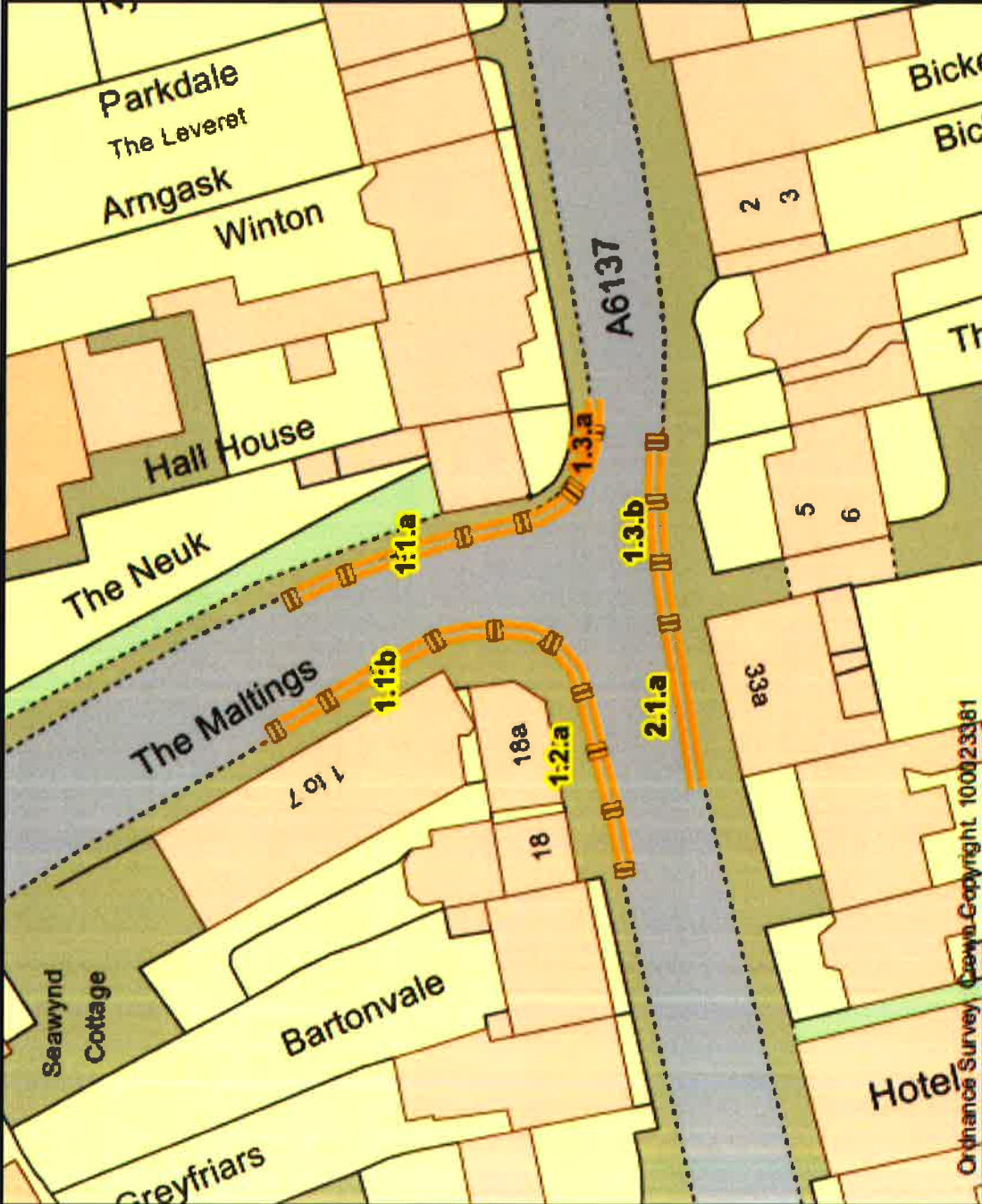
