Glasgow City Council in exercise of the powers conferred on them by the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Police Scotland hereby make the following Order:-

Citation and Commencement

This Order may be cited as "The Glasgow City Council (Pollokshields) (20 mph Speed Limit Zone) Order 2016" and shall come into operation on 19 September 2016.

The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to an Act of Parliament.

Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

Definitions

In this Order the following expressions have the meanings hereby assigned to them:-

"Vehicle" means a vehicle of any description and includes a machine or implement of any kind drawn or propelled along a road whether by animal or mechanical power.

Format of the Order

In the following Schedules of this Order there are Articles pertaining to each particular Schedule outlining the restrictions, permissions and conditions relevant to each particular Schedule. Each Schedule shall precede the Articles pertaining to that Schedule.

20mph Speed Limit

Road Name	Length of Road within the City of Glasgow
Albert Drive	From a point 11.0 metres east of the extended east kerbline of Shields Road eastwards to a point 20.0 metres west of the extended west kerbline of Darnley Street.
Forth Street	Its entire length.
Glenapp Street	Its entire length.
Herriet Street	Its entire length.
Kenmure Street	From a point 15.0 metres north of the extended northeast kerbline of Nithsdale Road northwards to the extended south kerbline of St Andrew's Road.
Kier Street	Its entire length.
Leslie Street	From a point 5.0 metres east of the extended east kerbline of Shields Road eastwards to its eastern extremity.
Leven Street	Its entire length.
Maxwell Road	From a point 10.0 metres east of the extended east kerbline of Shields Road eastwards to a point 18.0 metres west of the extended west kerbline of Darnley Street.
McCulloch Street	From a point 16.0 metres east of the extended east kerbline of Shields Road eastwards to its eastern extremity.
Melville Street	From a point 5.0 metres east of the extended east kerbline of Shields Road eastwards to its eastern extremity.
Nithsdale Place	From a point 8.0 metres north of the extended northeast kerbline of Nithsdale Road northwards to the extended south kerbline of Leven Street.
St Andrew's Road	From a point 15.0 metres east of the extended east kerbline of Shields Road eastwards then south-eastwards to a point 17.5 metres northwest of the extended north kerbline of Maxwell Road.

20mph Speed Limit

1. No person shall drive or cause or permit to be driven a vehicle on any of the lengths of road specified in the Schedule to this Order at a speed exceeding twenty miles per hour.
