

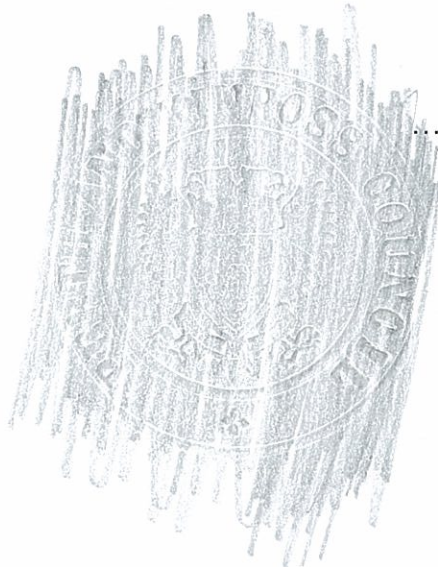
**PERTH AND KINROSS COUNCIL  
ROAD TRAFFIC REGULATION ACT 1984**

**PERTH AND KINROSS COUNCIL (OFF-STREET CAR PARKS)  
(VARIATION) (NO 1) ORDER 2015  
(NO. 14/15)**

Perth and Kinross Council in exercise of the powers conferred on them by Section 35(1) and (3) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (which Act of 1984 is hereinafter referred to as "the Act") and of all other powers enabling them in that behalf and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. This Order may be cited as "Perth and Kinross Council (Off-Street Car Parks) (Variation) (No 1) Order 2015 and shall come into operation on the Twenty-ninth day of May Two thousand and fifteen.
2. Perth and Kinross Council (Off Street Car Parks) Order 2015 is hereby varied and shall henceforth have effect subject to the amendments thereto specified and described in the Schedule hereto.

## SCHEDULE

The Schedule to the Perth & Kinross Council (Off-Street Car Parks) Order 2015 requires to be varied as follows:-

In section 12 **KINROSS**

- (I) **FREE CAR PARKS** after (d) **Kinross Park and Ride Car Park** (off Station Road Kinross)

add and insert the following in Column 1 :-

- (e) **Mill Street**

add and insert the following in Column 2 (Periods of Prohibition):- at all times.

add and insert the following in Column 3 (Classes of Prohibition):- Heavy Goods Vehicles

### **COUNCIL REASONS**

The Council wish to add this parking area to the "Off Street Car Parks Order" as the area of land on which it occupies has been redeveloped.
