PERTH AND KINROSS COUNCIL (PERTH TRAFFIC MANAGEMENT)
(VARIATION) (NO 10) ORDER 2017
(02/17)

Perth and Kinross Council in exercise of the powers conferred on them by Sections 1, 2, 4 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (which Act of 1984 is hereinafter referred to as "the Act") and of all other powers enabling them in that behalf and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

- 1 This Order may be cited as "Perth and Kinross Council (Perth Traffic Management) (Variation) (No 10) Order 2017" and shall come into operation on the Twenty-first day of January Two thousand and seventeen.
- 2 The Perth and Kinross Council (Perth Traffic Management) Consolidation Order 2015 is hereby varied and shall henceforth have effect subject to the amendments thereto specified and described in the Schedule to this Order.

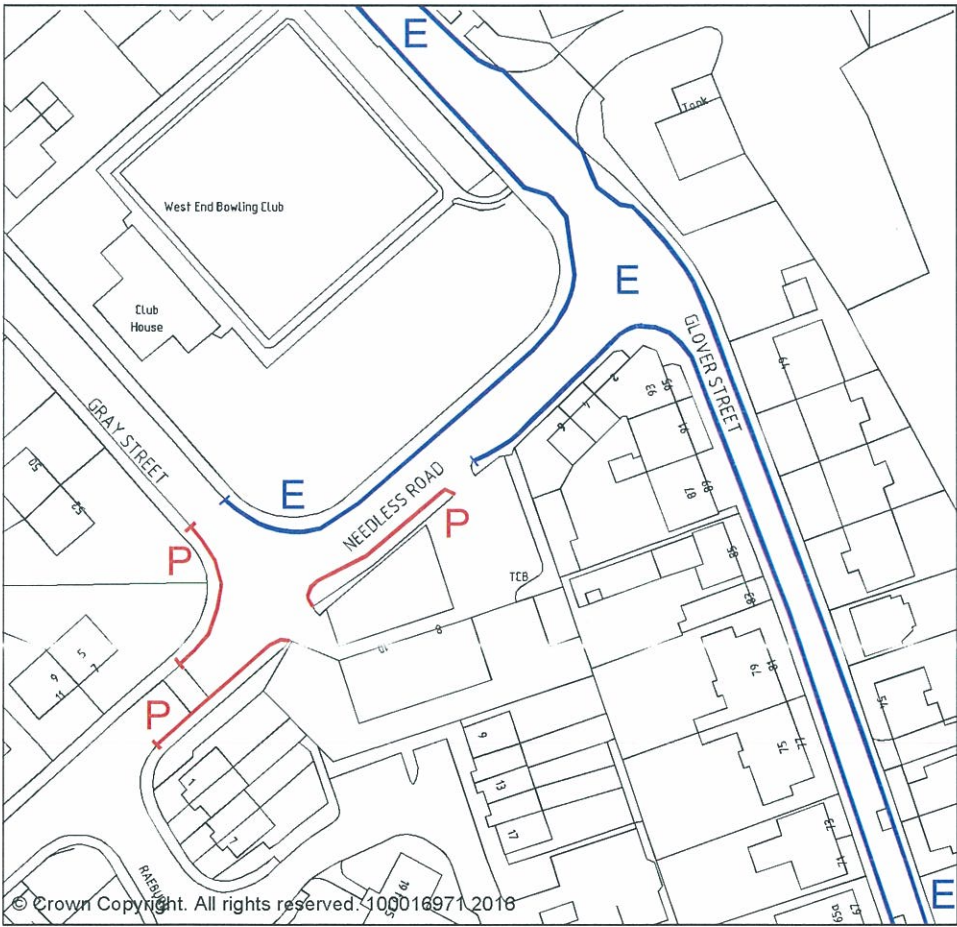
The Perth and Kinross Council Perth Traffic Management Consolidation Order 2015 requires to be varied as follows:-

At PART V NO WAITING AT ANY TIME

1. At part **80 NEEDLESS ROAD** delete the existing North Side and South Side (sub-sections (i) only) and substitute with the following,
 - (a) **North side** thereof
 - (i) for a distance of 95 metres or thereby westwards from the intersection of the kerbline thereof with the west kerbline of Glover Street:
 - (b) **South side** thereof
 - (i) for a distance of 105 metres or thereby westwards from the intersection of the kerbline thereof with the west kerbline of Glover Street:

Council Reasons

Due to the concerns of local residents and businesses the Council wishes to install No Waiting at Any Time waiting restrictions at Needless Road, Perth to (i) allow access and alleviate indiscriminate parking and (ii) improve the safety for pedestrians and all road users.
