**PERTH AND KINROSS COUNCIL (BLAIRGOWRIE TRAFFIC MANAGEMENT)**  
**(VARIATION) (NO 19) ORDER 2017**  
**(24/17)**

Perth and Kinross Council in exercise of the powers conferred on them by Sections 1, 2, 4, 32, 35, 44, 45, 46, 49 and 53 and Part IV of Schedule 9 and Schedule 10 to the Road Traffic Regulation Act 1984 (which Act of 1984 is hereinafter referred to as "the Act") and of all other powers enabling them in that behalf and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. This Order may be cited as the "Perth and Kinross Council (Blairgowrie Traffic Management) (Variation) (No 19) Order 2017" and shall come into operation on the Ninth day of December Two thousand and seventeen with the exception of Item 3 which has been deferred.
2. The Perth and Kinross Council (Blairgowrie Traffic Management) Order 1998 is hereby varied and shall henceforth have effect subject to the amendments thereto specified and described in the Schedule to this Order.

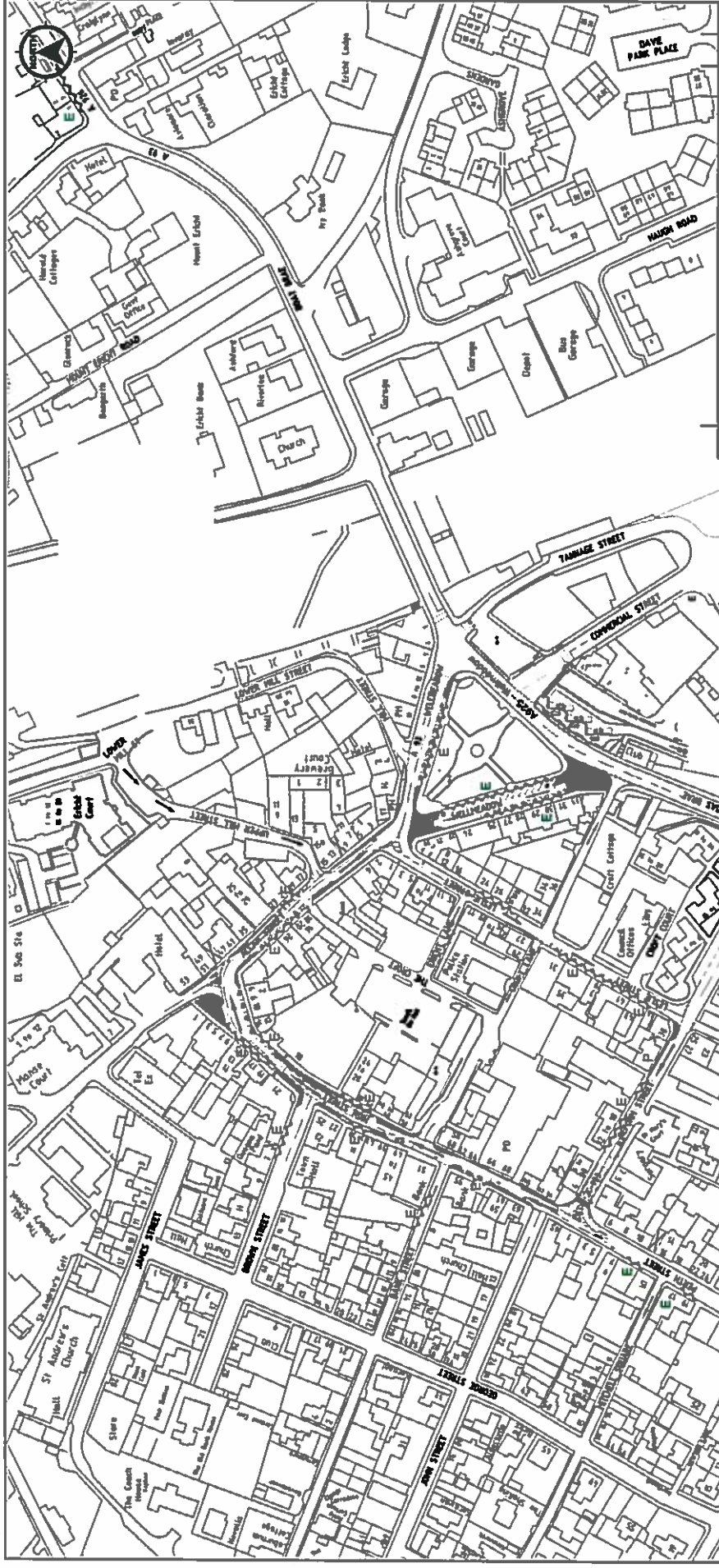
**SCHEDULE**


The Schedule to the Perth and Kinross Council (Blairgowrie Traffic Management) Order 1998, requires to be varied as follows:-

1. At **PART IV NO WAITING AT ANY TIME, 49. REFORM STREET (a) North Side** thereof, at (ii) in line one after the words "for a distance of" delete "25" and substitute "15".
2. At **PART VI WAITING LIMITED TO 30 MINUTES RETURN PROHIBITED WITHIN 30 MINUTES (MONDAY TO SATURDAY) (8.30 AM TO 5.30 PM)** at line 1 of the heading after the words "LIMITED TO" delete "30 MINUTES" and substitute with "1 HOUR".
3. At **PART VI WAITING LIMITED TO 30 MINUTES RETURN PROHIBITED WITHIN 30 MINUTES (MONDAY TO SATURDAY) (8.30 AM TO 5.30 PM), 1. ALLAN STREET** in line 1 after the words "for a distance of" delete "18" and substitute "38".
4. At **PART VI WAITING LIMITED TO 30 MINUTES RETURN PROHIBITED WITHIN 30 MINUTES (MONDAY TO SATURDAY) (8.30 AM TO 5.30 PM), 13. REFORM STREET** (ii) in line three after the words "for a distance of" delete "12" and substitute "30".

### **Council Reasons**

The Council wish to (a) change all 30 minute limited waiting times to 1 hour, (b) remove a section of no waiting at any time waiting restrictions on Reform Street and the Loading Bay on Allan Street, and (c) introduce 1 hour Limited Waiting to both locations. All these changes will allow longer term of parking and additional car parking provision.
