South Ayrshire Council in exercise of the powers conferred on it by Sections 1(1), 2(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended, and of all other enabling powers, and after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the Road Traffic Regulation Act 1984, hereby makes the following Order:-

PART I

GENERAL

Citation and commencement

1. This Order may be cited as the "South Ayrshire Council (Various Roads, Troon) (Prohibition of Waiting and Amendments) Order 2017" and shall come into operation on the 26th day of July 2017

Interpretation

2. a) In this Order the following expressions have the meanings hereby assigned to them—

"Schedule" means the Schedule annexed and signed as relative hereto;

"the 1984 Act" means the Road Traffic Regulation Act 1984.

- (a) A reference in this Order to any enactment is a reference to that enactment as amended by any subsequent enactment.
- (b) A reference in this Order to numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

PART II

Order to be amended—

3. The Order specified in Schedule 1 shall have effect subject to the amendments specified in that Schedule and as shown on Plans 1, 2, 3, 4 and 5 annexed and signed as relative hereto.

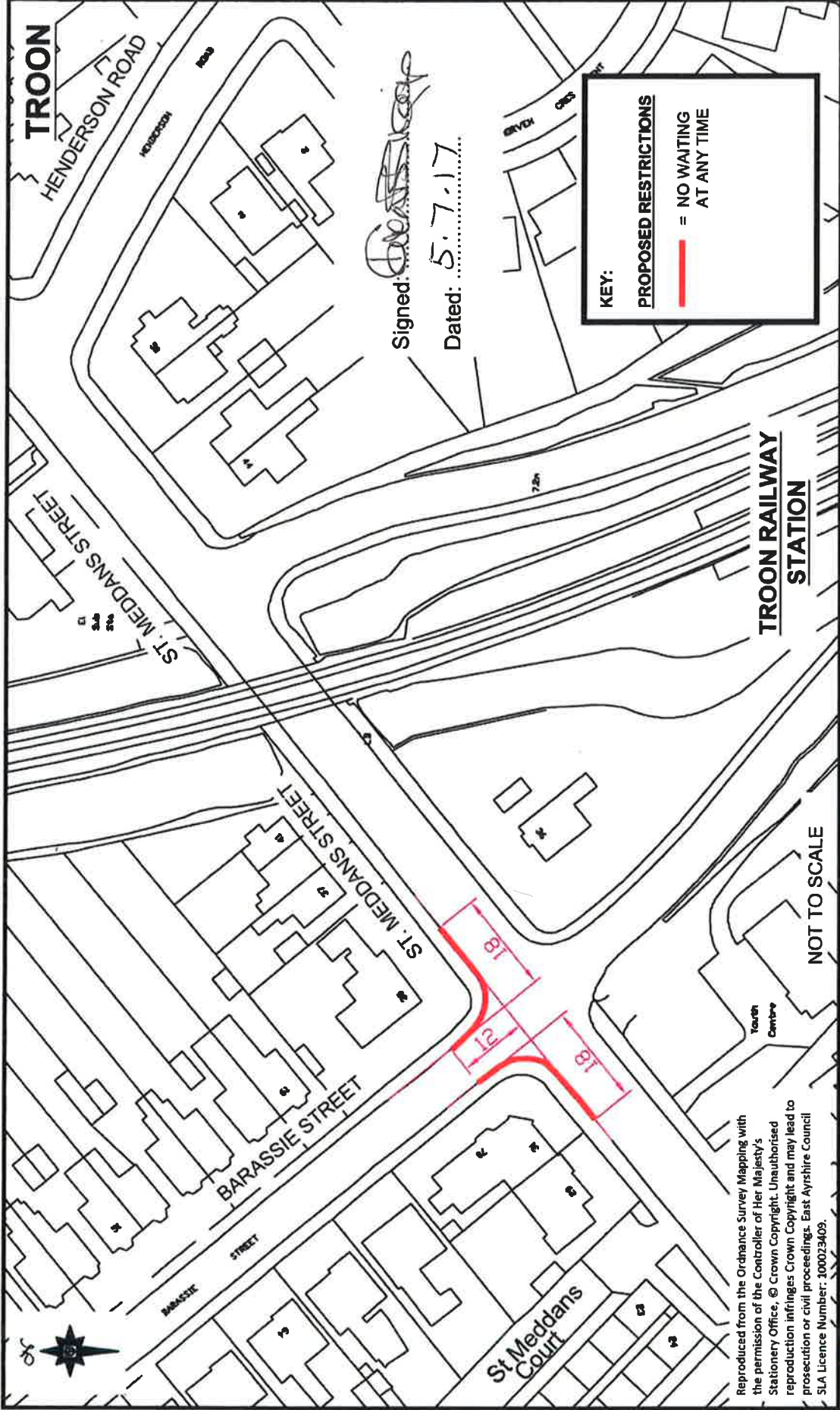

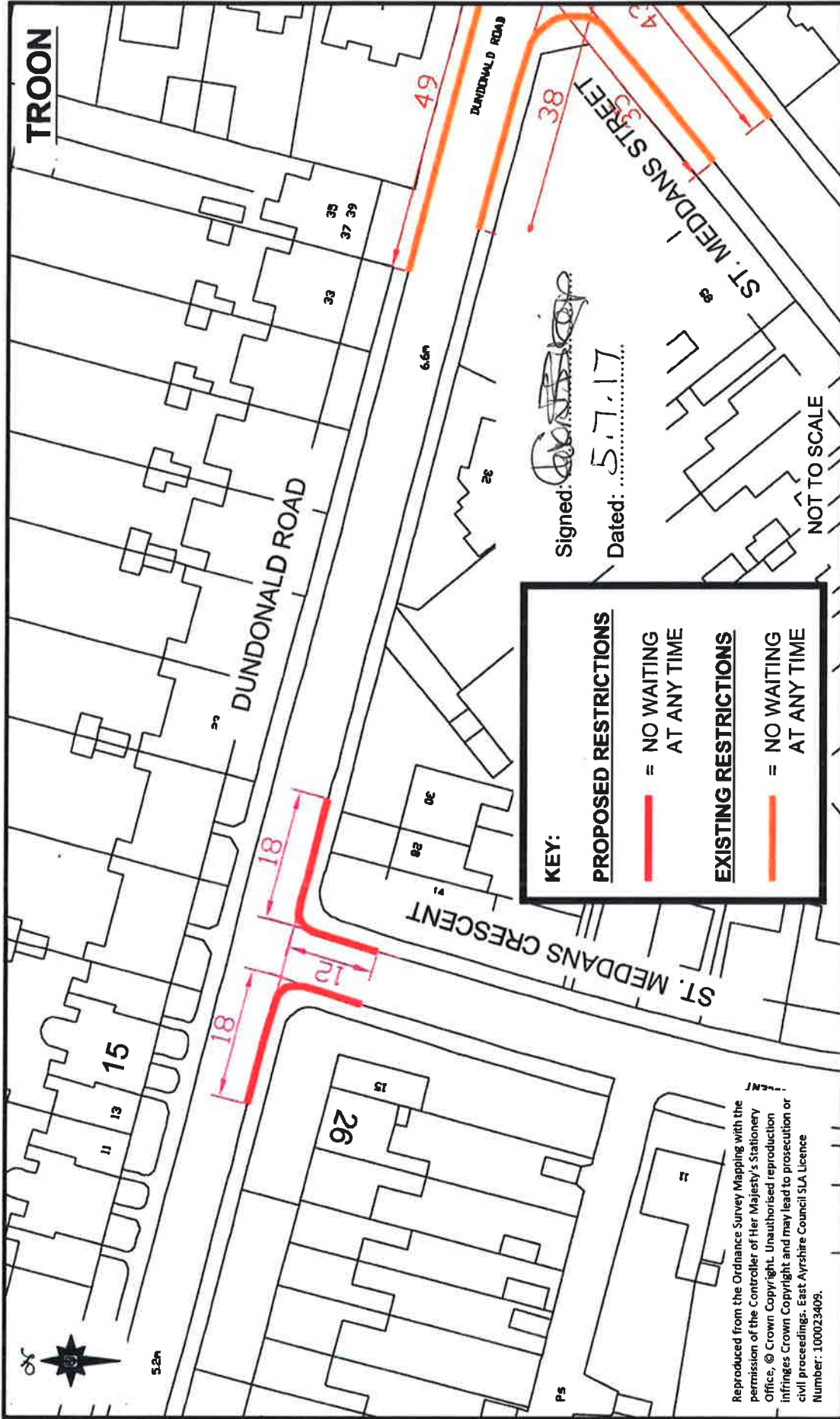

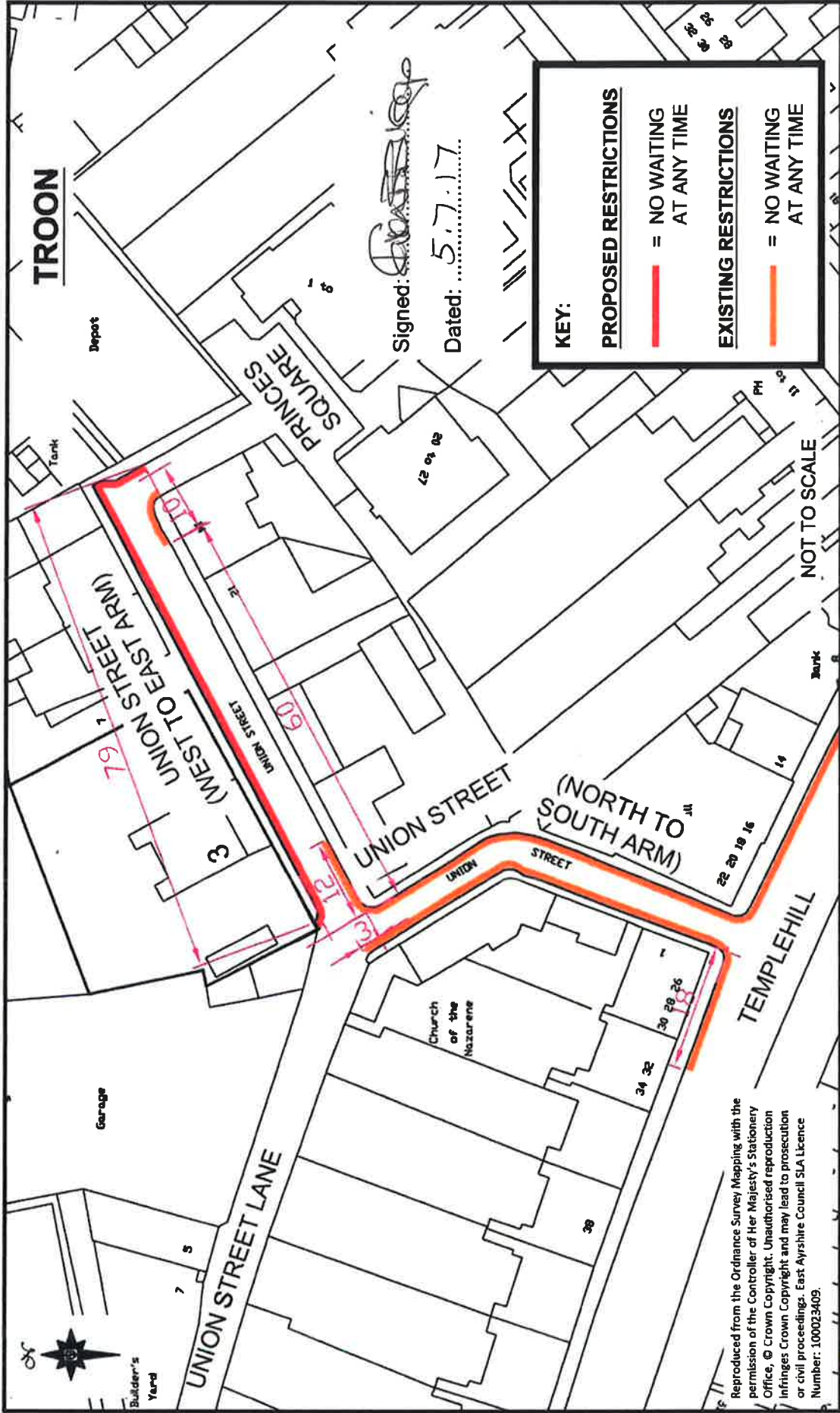
