**South Lanarkshire Council  
(Use of Off Street Parking Places)  
Consolidation Order 2011, Amendment No. 3  
Order 2013**

South Lanarkshire Council in exercise of the powers conferred on them by Sections 35(1) and (3), 3(A), 35A and 35B and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the Act hereby make the following order.

1. This order may be cited as "South Lanarkshire Council (Use of Off-street Parking Places) Consolidation Order 2011; Amendment No. 3 Order 2013" and shall come into operation on the 6<sup>th</sup> day of January 2014.
2. The order specified in the schedule to this order shall have the effect subject to the amendments specified in that schedule.
