**SOUTH LANARKSHIRE COUNCIL  
(USE OF OFF-STREET PARKING PLACES)  
CONSOLIDATION ORDER 2007, AMENDMENT NO. 2  
ORDER 2008**

South Lanarkshire Council in exercise of the powers conferred on them by Sections 35(1) and (3), 3(A), 35A and 35B and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Strathclyde Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order.

1. This Order may be cited as "South Lanarkshire Council (Use of Off-street Parking Places) Consolidation Order 2007, Amendment No. 2 Order 2008" and shall come into operation on the 17<sup>th</sup> day of November 2008.
2. The Order specified in the Schedule to this Order shall have the effect subject to the amendments specified in that Schedule.

## SCHEDULE

### Order to be amended

The South Lanarkshire Council (Use of Off-street Parking Places) Consolidation Order 2007

### Extent of amendment

**In Schedule 7, add the words:-**

In column 1 - under the heading "Location of parking place within South Lanarkshire";

"(Glebe Drive car park, Lanark)"

"The area of land bounded on its north side by South Vennel Council offices, on its east side by St Marys RC Church, on its south side by the Lanark Swimming baths and the rear of properties 1 to 9 Hyndford Road and on its west side by Glebe Court Sheltered Housing as shown cross hatched on Map 55 annexed."

In column 2 - under the heading "Restriction on use";

"Only vehicles displaying a valid "GLEBE" parking permit may park in the parking place referred to in column 1 opposite, other than any parking bay signed in accordance with diagram 661.1 of The Traffic Signs Regulations and General Directions 2002, where the maximum length of stay will be 90 minutes, no return within 180 minutes (permit holders will not be permitted to park in the short stay parking bays), Monday to Friday."

In column 3 – under the heading "Scale of Charges";

"Nil"

In column 1 - under the heading "Location of parking place within South Lanarkshire";

"(Wallace Court Disabled car park, Lanark)"

"The area of land bounded on its north side by Wallace Road car park and the rear of

46-48 Bannatyne Street, on its east side by the west gable of 68 Bannatyne Street, on its south side by South Vennel Council Offices and on its west side by Wallace Court as shown cross hatched on Map 56 annexed."

In column 2 - under the heading "Restriction on use";

"Only vehicles displaying a valid "GLEBE" parking permit may park, Monday to Friday, in the parking place referred to in column 1 opposite."

In column 3 – under the heading "Scale of Charges";

"Nil"

In column 1 - under the heading "Location of parking place within South Lanarkshire";

"(Wallace Court car park, Lanark)"

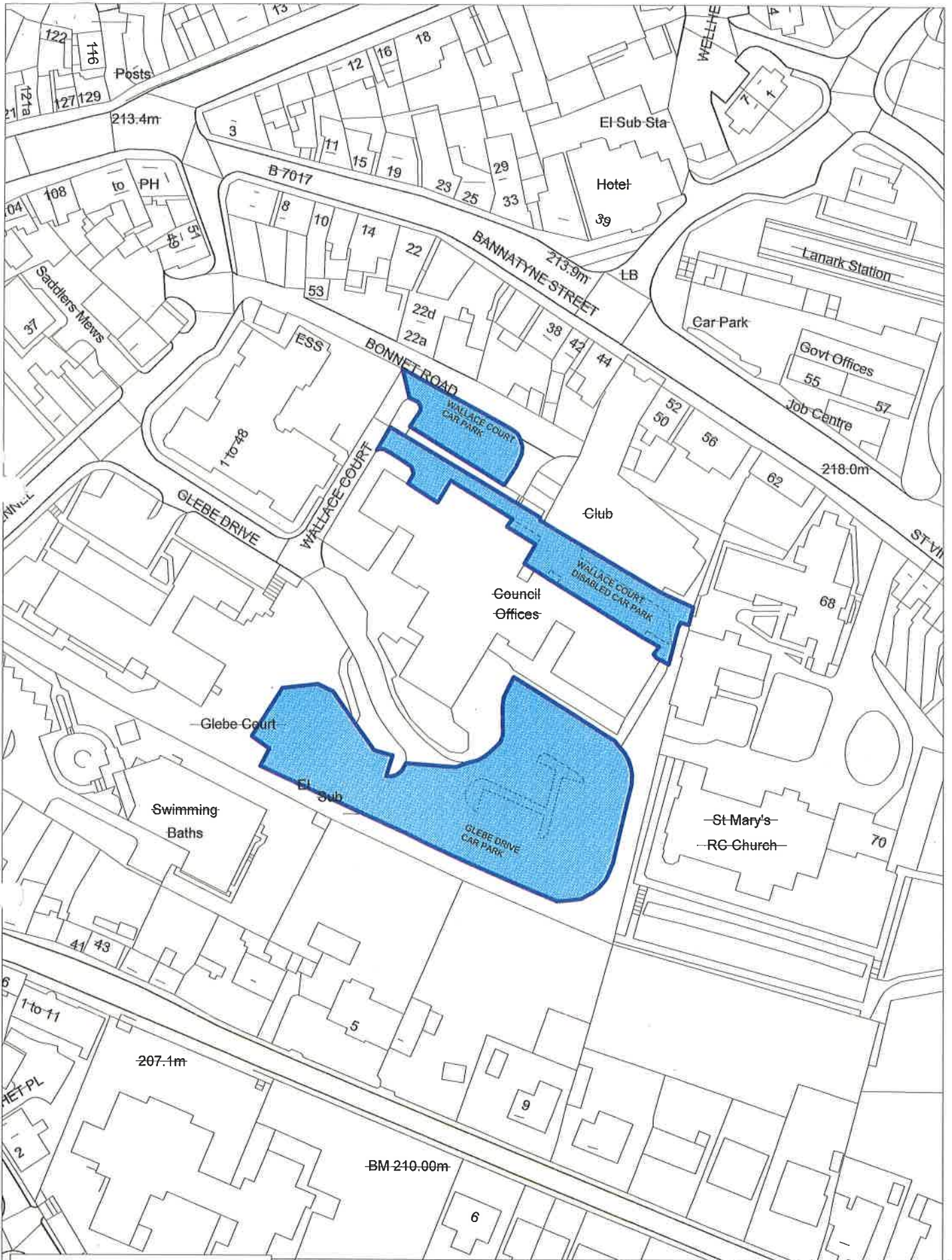
"The area of land bounded on its north side by Bonnet Road, on its east side by the rear of 46-48 Bannatyne Street, on its south side by Wallace Court Disabled car park and on its west side by Wallace Court as shown cross hatched on Map 57 annexed."

In column 2 - under the heading "Restriction on use";

"Only vehicles displaying a valid "GLEBE" parking permit may park in the parking place, Monday to Friday, referred to in column 1 opposite. Article 18, relative to parking within marked bays, will not apply to the parking place referred to on column 1 opposite."

In column 3 – under the heading "Scale of Charges";

"Nil"
